SCORING

- Scoring: May Target Very Good to Excellent Grant writing.
 - Applicant (A), Co-A, C, HQP Team is expected to contribute, and offer multiple opportunities for student researchers to contribute.
 - Proposal leaves no questions unanswered.
 - Think of words which describe a well written research proposal.
 - Institutional support is fully utilized Relative to Western, stage etc.
 - Time and Effort taken is made visible beyond the content form i.e., form.
 - External assessors are aware of the Canadian evaluation process.
 - No common challenges e.g., unjustified budget items.
