

Guide to the Writing Sample Applicants to the EdD Program

How long is the Writing Sample?

Each program has provided an approximate length with the caveat that the sample should be **no longer than** the maximum number of suggested pages.

EdD Applied Behaviour Analysis

About 10 pages, double spaced, excluding references

EdD Curriculum & Pedagogy

Between 10-20 pages, double spaced, excluding references

EdD Educational Leadership & EdD Equity, Diversity, and Social Justice

Between 15-20 pages double spaced, excluding references

May I submit a work on which I was a contributing author?

No. You must be the sole author of any work you submit.

Can I use Artificial Intelligence (AI) to create a Writing Sample?

 The goal of creating a Writing Sample is to help the admissions committee assess who you are as a potential EdD student, and if you are a good fit for the program.

Western has published <u>Provisional Guidance for the use of Generative AI in Graduate Studies.</u> In particular, they apply the Principles of **Accountability, Integrity, Transparency, Privacy and Data Security and Inclusion.** If you elect to use AI, you **must log its use** as part of the total document length. There is a useful table included here, to assist you to accurately describe what tasks you have allocated to AI.

Table 1 (below) can help you identify and log your use accurately.

Does the writing sample need citations?

Yes. The writing sample must be cited correctly throughout the paper.

How recent does the sample need to be?

There is no limit on when writing samples were written. You are welcome to use work you have submitted in other programs, as long as they adhere to all EdD program requirements.

Does the writing sample need to be a work that I have published?

- The writing sample may be published or unpublished work.
- Consider developing your writing sample from a well-developed and polished version or section of your
 - Masters research proposal/thesis/directed research project
 - Journal article
 - Graduate course writing

Does the writing sample need to be an essay?

- Not necessarily, but it must reflect the appropriate use of citation formatting.
- The Writing Sample should be based on an argument, and demonstrate your ability to present and defend a position, using evidence.
- The Writing Sample must follow the conventions of good writing including organization, structure, paragraphs, sentences, grammar, punctuation, etc.

Does the writing sample need to relate specifically to the program field?

The Admissions Committee typically prefers that writing samples be related to the field of study. However, this is not necessarily required. If you are feeling unsure of the suitability of your Writing Sample, please use this as an opportunity to produce original work that is related to the field of study.

If I am applying to the PhD in Education Studies, do these same guidelines apply?

 The PhD in Education Studies and the EdD programs are unique and may have different admittance requirements.
